What is the purpose of this update?

This document tells you how the Aurora RetirementPlus Age 50 has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: RetirementPlus age 50 is a representation of the RetirementPlus life cycle.

Strategy: This investment option invests 50% in the Aurora Growth Fund and 50% in the Aurora Future Focused Fund.

What are the risks of investing?ⁱ

Risk indicator for the Aurora RetirementPlus Age 50.



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



How has the fund performed?

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$872 (that is 8.72% of his initial \$10,000). Anthony also paid \$36.00 in other charges. This gives Anthony a total return after tax of \$756 for the year.

This shows the types of assets that the fund invests in.


Actual investment mix

Notes

- i. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years.
